* Bus Fee for AY 2024-25 shall be as follows:

Slab	Amount Per Month
upto 5KM	1230
upto 10KM	1690
Above 10KM upto 20KM	2070

Note:

- 1.Fee stated above must be paid on quarterly basis on or before 7th of first month of every quarter;
- 2.0.50% discount on Tuition Fee will be given on payment of Fee within the above stipulated time;
- 3.School objective is to have 100% cashless transactions and to promote banking transactions with online mode of payment against which an additional discount of 0.25% on Tuition Fee will be provided;
- 4.School will provide 3 days grace period and Fee paid within 10th of first month of the quarter will not attract Late fine but without 0.50% discount. If Fee paid after 10th date of the relevant month, Late fine will be charged as per rules. Humbly saying, "LATE FINE" is not our earning tools, rather we see and have defined it to achieve the goal of "Fine-Less School";
- 5.If, the quarterly school Fee with late fine is not paid till 15th of the second month of the quarter, the management reserves all the right to take Strict action.
- 6.For Child With Special Needs (CWSN)- Discount of 25% 75% on Tuition Fee will be given subject to degree of disabilities, doctor's certificate and the student must be of normal behaviour, such eligible students can apply to the Trust at the time of admission itself with all required documents. The Dadiji Mandir Trust Board reserve the right to approve or disapprove the application and the decision of the trust can not be challenged.
- 7.If two children of same parent are studying in our school, then discount of 10% on Tuition Fee of younger child will be provided for Academic year 2024-25.
- 8.The School bus /van will pickup & drop the students from schedule stop at schedule time only. Due to breakdown or some other unavoidable circumstances, if bus is delayed Students/Parents can not blame or held responsible the school/driver/helper.
- 9.If there is any abnormal rise in fuel price and others, the Bus Fee is subject to change after informing in the official school parents group.

 10.If due to some forced and unavoidable circumstances, any bus is completely breakdown, the management will take all possible measures for alternate vehicle and if not possible the Students/Parents can not blame or held responsible the school.
- 11. The management reserves all right to amend or introduce required terms and conditions as and when required and same will be shared in PRC & Parent's school official what sapp group.
- 12. School has limited Seats for each class and the management reserves all the right to take Strict action if confirmation is not received within given time frame to parents.
